"Refugees, Forced Migration and Peace" 26th May – 23rd June Universidad Pontificia Comillas

ABSTRACT

The Refugees, Forced Migration, and Peace program, hosted by Universidad Pontificia Comillas from May 26 to June 26, is a comprehensive academic and field-based initiative addressing key issues related to forced migration, refugee protection, and peacebuilding. Through a series of seminars, workshops, and field visits, the program explores interdisciplinary approaches to migration, asylum policies, human rights, media narratives, climate-induced displacement, youth empowerment, human trafficking, and gender perspectives. The program brings together academics, practitioners, and students to engage in discussions on the legal, political, and social dimensions of migration. Special focus is given to the European asylum framework, Islamophobia, child protection, psychosocial and economic assistance, and political advocacy. Participants will also undertake field visits to migrationfocused organizations, including Délégation Diocésaine des Migrations and Red Acoge, gaining firsthand insight into migrant support mechanisms. A highlight of the program is a field trip to Melilla-Nadur, where participants will analyze border dynamics, migration flows, and the role of NGOs and policymakers in addressing border challenges. The program concludes with reflective workshops aimed at conceptualizing key findings and developing future research and policy actions related to peace and forced migration.

- Context and presentation of the project Data Culture in Human Trafficking II: The project seeks to shed light on both the hidden aspects of crime (those that are not reported) and the underlying factors that influence whether crimes are reported or remain unnoticed. By combining both quantitative and qualitative methods, the study provides a comprehensive view of crime dynamics that goes beyond what is officially documented. The project is divided into two main phases: one focusing on quantitative data collection and the other focusing on qualitative insights (interviews, focus groups).
- Results of the Dark Figure (**Results of the Quantitative Methodology MSE**) and Beyond the Hidden Figure (**Results of the Qualitative Methodology**)
- Recommendations: Based on the findings from both the quantitative and qualitative data, several recommendations have emerged to address the dark figure of crime and improve crime reporting.
