### EVALUATION STATEMENT II

The international economic and financial crisis, the effects of which began to manifest themselves in early 2008, highlighted the enormous weaknesses in the institutional and governance model of the European Union (EU) to provide operational solutions that would reverse the economic cycle.

As analysed throughout the manual, during the last decade a review and reform process has been carried out, where certain advances have been made in this section.

Taking into consideration the book being evaluated, as well as the readings recommended below and the complementary links of the virtual course:

Conduct a discussion paper in which you analyse the new EU action strategy, in terms of economic governance, to face the negative effects of the crisis caused by the pandemic and war in Ukraine.

You can structure your essay in three parts:

- 1. Introduction:** Where you must provide a detailed understanding of the problems that community governance has to respond to economic crises.
- 2. Development:** It is important that the author develops his discussion based on solid research that allows him to present different points of view on the subject in question. To improve the quality of your essay, you can examine the economic measures carried out, the terms of their implementation and their conditions and / or study the possible lines of improvement and the actions to be taken.
- 3. Conclusion:** The student must synthesize the most important milestones of their work, posing the challenges that need to be addressed to solve it (it is not strictly a summary). Although the pros and cons of each argument made are analyzed, the student can issue their own evaluations in this section (but opinions should only be included in this section, not in previous sections). Any assessment has to be properly substantiated.

Although you can consult both the basic bibliography and any external source, as long as it is rigorous, to build your essay we recommend a series of texts that can serve as support:

### **Evaluation criteria:**

The text will be presented, with 2.5 cm margins, in Times New Roman (12 pt) and 1.5 spacing. The extension will not be more than 6 pages nor less than 3.

The text will be written in accordance with the established academic standards, will include footnotes and a list of sources and bibliography, and must have a maximum length of between 2000 words. Remember that if you insert graphics, images or tables, you must title and number them (indicate their source in the caption and comment on them in the text).

In the case of detecting plagiarism, it will imply a suspension.
